This change window is for elementary schools with ECE -5th graders and 6th graders at Montessori schools. 6th -8th graders at ECE-8th grade schools are considered secondary students and not eligible for this change window. 2. Due to health restrictions on the number of interactions with adults and other students outside of your child's cohort, some services related to special education, 504 Plan, English Language Acquisition (ELA), Gifted and Talented (GT), or others might be delivered through live streaming into your child's classroom. 3. The 100% virtual learning option will be available on an extremely limited basis for ECE students and it may require students to be assigned to a different teacher in the spring semester. Some charter schools may offer a virtual learning option for ECE – please check with your school. 4. To the extent your child is on an individualized education plan (IEP) or 504 Plan, choices related to online-only learning may need to be reviewed with your child's IEP or 504 Team to determine whether your child has services or needs that can only be addressed in an in-person environment. INTERNET ACCESS If your student is enrolled in a Virtual Program, or in the event that your student's school is required to transition to remote learning during the school year, your student will need internet access. If you select "yes," you are indicating that your student has reliable access to the internet at home, either through a personal account or district-issued hotspot. If you select "no," you are indicating that your student needs internet access at home and you may be contacted about next steps.
